New meeting held in Madrid, agreed targets for 2050, which seems weak.</li> <li>USA retains 25% import duties on all steel products.</li> <li>USA/China tariff trade war seems to be improving. Tariffs have been reduced to 7.5% on \$120bn worth, but 25% remains on \$250bn. China agreed to increase purchases on Industrial components and farm goods.. China retains tariffs on \$100bn worth. No timeline yet!</li> <li>Mexico, Canada NAFTA agreement. Article 10 of EC98/83 deleted, and “mutual recognition” removed.</li> <li>New standardisation mandate issued under CPR.</li> <li>EDW issues are:             <ul style="list-style-type: none"> <li>CPR does not cover Pumps &amp; Seals etc,</li> <li>Need agreed single test based on 4MS tests</li> <li>4 tests is too expensive.</li> </ul> </li> <li>EDW responded to 10 MS proposal. ESA has submitted a strong support for 4MS style single testing.</li> <li>EDW has issued a strong support presentation on all the key issues and ESA fully supports this.</li> <li>The EU ENVI committee new revision of the Drinking Water Directive adopted by European Parliament on 27.3.19. All materials and products to be subject to the same high Hygenic standards, and harmonised tests.</li> <li>Provisional agreement reached at Trilogue on 18.12.19</li> <li>New Article 10 written covering products and materials, covering regulation EU 305/2011</li> <li>Luca Ibelli replaced by Guy Parker. Volker Meyer still leading EDW.</li> </ul>	<ul style="list-style-type: none"> <li>New EDW web site has all activities shown and explanations for documents. Worth a visit.</li> <li>EDW suggest tests for assemblies as well.</li> <li>Proposed options issued, with recommendation to follow option 3. ESA not happy with CPR route as no sealing device test/ standards exist under CPR</li> <li>Clarification note written on what CPR means..</li> <li>ESA responded to EDW request stating this leaves sealing devices without standard test, but supporting EDW as it is best option.</li> <li>EDW has responded to Commission Implementing Decision on drinking water policies.</li> <li>EU Council common position on DWD now issued. BPMA issued trade rules updates</b></li> <li>New trade deal with USA is big prize for UK, if it is possible?</li> <li>New UK approval (UKCA) to replace CE mark, at 31.12.2020. We must assume Corvid-19 will delay negotiations, with UK PM currently in self isolation.</li> <li>UK ESA Members advised to apply for Authorised Economic Operator (AEO) trusted trader status. HMRC to issue Economic Operator Registration &amp; Identification numbers (EORI) in UK</li> <li>Ensure ESA UK members use Single Administrative document.</li> <li>UK Gov. recommending “facilitated customs agreement”.</li> </ul>
